RE: No Contact

Mr. Bertrand,

This letter shall serve as notice and demand to cease and desist any and all contact with Rachel Mastrogiacomio, her husband, and family.

According to public court records under *State of Minnesota v. Jacob Andrew Bertrand*, Cause No. 19HA-CR-16-3812 (Dakota County District Court, 2016), in 2010, you committed Criminal Sexual Conduct against Mrs. Mastrogiacomio, then née Rachel Olson, during the Holy Sacrifice of the Mass, while you were a newly ordained Roman Catholic Priest. The public record states that you were charged with felony Criminal Sexual Conduct in the 3rd Degree (Clergy) (During Religious Advice Meeting) for that incident and subsequently accepted a plea bargain including but not limited to:

1. Remain law-abiding,
2. Follow all instructions of probation,
3. Authorize release of PSI/Psychological Evaluations, to court ordered programs,
- 4. No contact with victim(s), (emphasis added)**
5. Submit to Polygraph Examinations as Directed,
6. Cooperate with the search of your person, residence,, vehicle, workplace, property, and things as directed by your probation officer.,
7. Submit to Random Searches,
8. Not Possess/Use Any Pornographic/Sexually Explicit Material,
9. Follow all State and Federal criminal laws.,
10. Contact your probation officer as directed.,
11. Tell your probation officer within 72 hours if you have, contact with law enforcement.,
12. Tell your probation officer within 72 hours if you are, charged with any new crime.,
13. Tell your probation officer within 72 hours if you change, your address, employment, or telephone number.,
14. Sign releases of information as directed.,
15. Give a DNA sample when directed.,
16. Conditions, other, Do not engage in spiritual advice or counseling. You can not be alone with any females in any organizational settings for whom you have supervisory authority. Cooperate with probation transfer to California. - If this sentence is ever

executed it is subject to a 10 year conditional release period. Where ever you live you must follow/subject to registration requirements of that state.,

17. Attend sex offender program, you need to do an intake assessment for out patient treatment, sign releases from St. Luke's treatment- Follow all recs of the intake assessment.

On June 16, 2025, in the matter of *State of Minnesota v. Jacob Andrew Bertrand*, the attached documents specify a detailed account of events and acceptance of plea as to the charges.

Your latest contact with Mrs. Mastrogiamo, her husband, his employer, and other individuals this past May 2025, threatening legal action if Mrs. Mastrogiamo went public with her story by publishing a book, has caused her significant mental distress and has triggered horrific memories of her experiences during your victimization of her directly related to your crimes against her.

Do not contact Mrs. Mastrogiamo or her family again. All future communications, if any, must be directed solely to counsel at the contact information provided below.
