STATEMENT

At the request of the Dakota County Attorney's Office, on 06-08-16 I, Inv. Chad Willson #2238, attempted to make contact with Bertrand and the Diocese of Raleigh to obtain statements or any other information related to the church investigation in 2014. Mastrogiacomo provided a copy of a letter she received from John Pendergrass who took notes at the time she reported the abuse to the church in Raleigh.

I called St. Vincent de Paul in San Diego, CA where Bertrand is the Associate Pastor. He was not available but I was given his email address. I sent Bertrand an email with my contact information. On 06-10-16 I received a letter from Marc Carlos, an attorney with the firm Bardsley & Carlos, LLP in San Diego, CA. The letter was to inform me that Carlos was representing Bertrand and any further contact was to be through him.

On about 06-14-16 I received a phone call from Carlos' investigator, Dennis, who was conducting an investigation for the law firm to determine the facts and evidence relating to the matter. Dennis told me after his investigation was complete Carlos would make a decision on allowing Bertrand to make any statements to me in this case. I was supposed to be notified within one week on that decision and have not been contacted since.
